### **NINE TENTHS OF THE LAW? ADVERSE POSSESSION AND TENANT ENCROACHMENT IN THE MODERN WORLD**

Drawing on their practical experience and recent case law, Jamie Sutherland and Judge Ewan Paton consider such issues as the workings of the boundary condition for the adverse possession of registered land, the degree to which successive squatters can aggregate periods of possession, and whether the doctrine by which tenants can add to their demised premises by encroachment is based on adverse possession or estoppel. ### **ILLUMINATING NUISANCE AT BANKSIDE**

Fancourt J's judgment in *Cooper & others v Ludgate House Limited* [2024] EWHC 11724 (Ch), in which he awarded damages of £1.25m in lieu of an injunction, has been welcomed by practitioners in the rights of light world. It grappled with some of the less well litigated areas of rights of light law, as well as giving a fresh take on a modern-day rights of light dispute, and reiterated the importance of the Supreme Court decision in *Fen Tigers*. In this talk, Kevin Francis will examine the Court's analysis of how light should be measured; and the merits of the Waldram method compared with both the Radiance method and the median daylight illuminance and median daylight approach. Elizabeth Fitzgerald will look at Fancourt J's approach to negotiating damages, and analyse the way in which damages were assessed.

## **WHEN CONTRACTS FOR THE SALE OF LAND GO WRONG: PULL THE RIPCORD OR PUSH ON THROUGH?**

An innocent party faced with a breach of a contract for the sale of land will have to decide whether the breach enables them to escape the contract and claim damages or whether they can instead compel the defaulting party to complete. In this talk, Lord Justice Newey and Nat Duckworth KC will consider a range of issues, including when a party is truly 'ready, able and willing' to complete, the impact of judgments such as *Olam Global Agri Pte Ltd v Holbud Ltd* [2025] EWHC 3187 (Comm) on the quantification of damages, and the availability of specific performance as a remedy for both vendors and purchasers.
